Managers' Report

A. Comcast Service Upgrade

Micah presented a proposal from Comcast to upgrade the internet speeds at the BTPWD office. Comcast is currently offering a promotional price on this upgraded service at the same price as our old service (\$214.90/month) with a thirty-six (36) month agreement. This upgraded service will allow for a future IT consultant to more easily assist BTPWD staff remotely.

Tom Husek made a motion to approve the 36 month contract with Comcast to upgrade internet speeds: second by Mike Kirk. All Ayes – motion carried. Absent: John Emmert.

B. Kings Mill Repair

Micah informed the trustees that a service line repair had been performed by G.A. Rich on Crossbow Dr. It was found that the corporation stop, the valve directly attached

to the water-main, was off. Micah explained that typical water main construction stipulates the corporation stop to be on at the completion of the project.

Micah requested that the trustees approve BTPWD Attorney, Joe Dehn, to prepare a letter of collection requesting reimbursement from the developer, Kings Mill Acres, for the GA Rich repair invoice.

Dave Baugh made a motion to move forward with Attorney Joe Dehn preparing a letter to Kings Mill Acres, LLC: second by Greg Allen. All Ayes – motion carried. Absent: John Emmert.
